Background

National Research Ethics Committees (NRECs) are responsible for reviewing research proposals in prescribed areas of health research, and to deliver a single national ethics opinion. They play a key role to ensure the safety, dignity and well-being of health research participants.

In 2021, the National Office for Research Ethics Committees established National Research Ethics Committees (NRECs) in specific areas of health research as requested by the Minister for Health to enable Ireland to meet its regulatory requirements under existing EU regulations; the Clinical Trial Regulation (EU No 536/2014), Medical Device Regulation (EU No 2017/745) and *In Vitro* Diagnostic Device Regulation (EU No 2017/746).

These NRECs established have a specific remit to assess the ethical aspects of health research studies in the following areas:

- Clinical trials for investigational medicinal products for human use (NREC-CT A, B, C & D)
- Clinical investigations for medical devices (NREC-MD)
- Performance studies for *in vitro* diagnostic devices (NREC-MD)

As the national system of ethics review is an integral infrastructure within the Irish health research ecosystem, it is critical that the National Office ensures the NRECs are constituted with a diverse membership with skills, lived experience, interests and backgrounds reflective of Irish society to deliver robust ethics opinions.

From time to time, the National Office may seek additional members to fill any vacancies that might arise and to assist the NRECs as subject matter experts throughout the year. To that end, the National Office now accepts Expressions of Interest applications for membership of the National Research Ethics Committees on a rolling basis.

Membership of the NRECs provides an exciting and rare opportunity to support Irish research, to gain insight into forefront health developments and new legislative regulatory frameworks and to ensure that Irish research is underpinned by the highest standards of ethical research practice.

The National Office facilitates equal opportunity membership and welcomes Expressions of Interest from applicants inclusive of race, religion, ethnicity, gender, sexual orientation, responsibilities for dependents, age, disability, civil status and geographic location.

Reasons to join a National Research Ethics Committee

- Contribute to safeguarding of safety, dignity and well-being of research participants
- Contribute to health research at a national and international level
- Gain insight into emerging European regulatory changes and best practice in research ethics
- Gain insight into forefront research and emerging areas of healthcare and treatments
- Enhance your professional & personal development through your membership on a NREC and the benefit of continuous member training opportunities, such as 'Lunch & Learn' speaker series

What does it mean to be a member of a National Research Ethics Committee?

NRECs are the essential component of the national system of research ethics review in Ireland for regulated areas of research. By modelling and sharing best practice, NREC members have the opportunity to deliver quality and best practice ethics opinions through a robust and transparent decision-making process across the spectrum of research in Ireland.

Members are appointed by the Minister for Health, and NRECs as a whole report to the Minister. The purpose, structure, and scope of the NRECs are defined by their Terms of Reference, which are provided at appointment and are informed by the legislation that prescribe how the NRECs are constituted and operate.^{1 2 3}

Members are appointed for three years and may be eligible for reappointment for another term.

Opinions delivered by NRECs on applications for research ethics assessment are independent and consensus-based.

NREC meetings require a quorum for decisions, and detailed minutes of meetings and opinions delivered are made publicly available.⁴ The transparency of the decision-making process aims to engender the trust of the research community and wider public.

All NRECs have a Chairperson and two Deputy Chairpersons, whose tenure is four years.

Membership of an NREC is an important and valued public service role requiring commitment. The National Office acknowledges and appreciates the time committed by each committee member.

Terms of membership

- Observe the Terms of Reference for the NREC provided by the National Office;
- Actively participate in the majority of NREC monthly meetings, confirming attendance and any foreseen absences in advance;
- Prepare ahead of NREC meetings including review of applications, completion of an ethics assessment report and assist with reviewing applicant responses to ethics considerations raised;
- Commit to a consensus-based approach to decision-making under the direction of the Chairperson;
- Respect the opinions of all fellow NREC Members, the diversity of which enrich the NREC process;
- Work collaboratively with the Chairperson, fellow NREC Members and National Office team to ensure the highest standards of ethics review and efficiency in the process;
- Maintain the strictest confidentiality on proprietary information;
- Declare all affiliations and any interests, actual conflicts or potential;
- Attend and complete the requisite training provided;
- Be comfortable using the basic IT tools that facilitate NREC work;
- Uphold the National Office's values of trust and transparency in NREC work.

Selection Process

Expressions of Interest for the NREC are managed by the National Office for Research Ethics Committees. All Expression of Interest are acknowledged by the National Office on receipt. As opportunities for membership on a NREC arise, the National Office reviews Expressions of Interest in consultation with the Chairpersons, and/or Deputy Chairpersons and/or external experts as required, for appropriate expertise.

Applicants may be invited to meet the assessment panel to discuss their Expression of Interest further.

Expressions of Interest are evaluated for demonstration of the skills, lived experiences and attributes necessary for effective NREC participation.

Member selection is based on the diversity of skills, qualifications, subject matter expertise, interests and backgrounds required to deliver opinions on applications made to the NRECs. Selection is also informed by appropriate representation of both 'expert' and 'lay' members as provided for in Irish legislation.

Where prospective members are deemed suitable for selection, the National Office will put forward to the Minister for Health for recommendation for appointment to a NREC.

Where no vacancy is immediately available on a NREC, suitable applicants, with their permission will be placed on a reserve panel, with a view to being contacted as future opportunities for membership arise. Given the breadth of expertise and perspectives required and the anticipated expansion of the scope of NRECs over time, individuals on this panel may also be approached from time to time to contribute to NREC deliberations based on their expertise and experience.

Recognition & Expenses

NREC membership is broadly considered a voluntary role in public service. The NREC review system is entirely dependent on this voluntary commitment, availability, expertise and experience of professionals, patients and public representatives.

All members appointed are recognised as expert ethics assessors drawing on technical, scientific, experiential, or other subject matter expertise required to deliver expert assessments on ethic applications.

Training for and participation in NREC meetings may be eligible for recognition for Continuing Professional Development (CPD) points. The National Office team can provide confirmation of attendance and other evidence to support CPD applications. Reasonable out-of-pocket and receipted expenses directly associated with NREC business will be reimbursed to all Members (eg travel to meetings where necessary, stationery).

Time commitment

Committee meetings are convened monthly, mostly virtually/remotely and may occasionally be convened in person. The meeting schedule for the year will be provided at appointment by the National Office.

NREC meetings are scheduled within business hours on a recurring day scheduled in advance and will typically be 2 - 3 hours in duration.

Additional NREC related work, such as preparation for the meetings, completion of written expert ethics assessment reports, reviewing of applicant responses to considerations raised by the NRECs, can amount to at least 2 - 4 hours per month.

Generally NRECs meet 10-12 times per year, and NREC membership and associated work can range from 4 - 8 hours a month.

National Office team and supports

Appointed Members will receive training, access to the electronic tools necessary to conduct Committee work, and operational and technical expert support from the dedicated National Office team.

The National Office comprises a vibrant team of dynamic and dedicated high-performing professionals whose core values of integrity, knowledge, collegiality, and transparency drive their work of delivering an agile and trusted office in national public service.

Each NREC has a dedicated Programme Manager and is supported by other team members within the National Office.
